Training Memberships (has volunteer expectation) Individual \$50 per year.... Family \$75 per year
 Training Memberships are available for individuals and families. A Training Membership allows the individual or family members to train retrieving dogs at Benton Retriever Grounds (grounds) during the current training year. *Note that the AKC does not allow training on the grounds during AKC sponsored events.* Training membership holders are expected to volunteer to help at club events or BRG sponsored workdays during the current training year. The volunteer expectation is 24 hours for individuals and 48 hours for families where both adults are involved in training/running dogs.

Training Member Work Deposit..... \$250
 Training members are required to pay a \$250 deposit. The deposit will be used to offset the costs associated with putting on an event should the Training Member/s be unable to put in some or all volunteer hours. The member’s deposit and volunteer hours will be tracked by the club treasurer. Training Members have two reimbursement options: a) have the deposit rolled over to the next training year or b) have the deposit reimbursed after completion of volunteer hours. It is preferred that you select which option you prefer at signup. If you previously rolled over your deposit, circle “Rollover” and pay \$50 or \$75 as applicable.

A Training Member may elect to forfeit their Work Deposit at signup in lieu of volunteering their time.

Club Membership (no volunteer expectation) \$50 per year
 A Club Membership allows the member to:

- Show support for the club and receive the club new letter and all correspondence
- Assist a Training Member in training of the Training Member’s dog/s. *example – The Club Member can throw birds for the Training Member, but it does not allow the Club Member to train a dog at BRG.*
- Complete their volunteer hours for HCARC or MFTA if they have a Training Membership at MFTA.
